The Town of Ansted held its regular monthly council meeting on Thursday, April 4, 2024, at the Ansted Council Chambers, located at 104 Cemetery Street, Ansted, West Virginia. Those in attendance were Mayor Stephen Pridemore, Councilmembers Josh Crist, Greg Brewer, Anthony Harmon, and Holly Jeffers (absent were Councilman Josh Cameron and Recorder Robert T. Wilson), Clerk & Acting-Recorder Siobhan Wilson, and citizen Richard McVey.

Mayor Pridemore called the meeting to order at 6:30 PM. Councilman Greg Brewer led the meeting off with the Pledge of Allegiance and Mayor Pridemore led everyone in prayer.

Clerk Siobhan Wilson read the minutes from the March 2024 council meeting. Josh Crist made a motion to approve the minutes as read, seconded by Greg Brewer, and the motion passed unanimously.

Clerk Siobhan Wilson read the financial reports. Josh Crist made a motion to accept the financials as read. Greg Brewer seconded the motion and it passed unanimously.

Mayor Pridemore gave Council a sewer update. He let everyone know about the Public Hearing and how Council had approved moving forward with phases 2 & 3 of the sewer upgrade project. Phase 2 will be the Sewer Plant upgrade and Phase 3 will be sewer line replacement and repairs. He also let everyone know that the Sewer Department has recently received notifications from the WV DEP for overflows and other various issues at the Sewer Plant. Thrasher Engineering and our lawyers are currently working on a response.

Clerk Siobhan Wilson read Sewer Resolution #41 (attached). Josh Crist made a motion to approve the resolution as read, seconded by Anthony Harmon, motion passed unanimously.

Mayor Pridemore presented Council with a copy of the current Business License application and a copy of a proposed new version changing the name of some business categories and the cost of one. The proposed changes are as follows:

1. General Store (includes soft drinks, tobacco, and tobacco products) becomes General

- 2. Special Store (Seasonal) becomes Professional Services
- 3. Restaurants (eating establishments) becomes Restaurants (easting establishments, food truck)
- 4. Theater becomes Real Estate Brokers and the fee changes from \$20 to \$15 per year. Councilman Greg Brewer made a motion to approve the new proposed Business License application to be effective immediately. Anthony Harmon seconded, and the motion passed unanimously.

Mayor Pridemore presented Council with the 2nd Budget Revision of the fiscal year for the General Fund (attached). After going over the revision, Greg Brewer made a motion to accept the revision as presented, Josh Crist seconded, and the motion passed unanimously.

In conjunction with the budget revision, Mayor Pridemore presented Council with Street Project plans, which were a major reason for the need of a revision. He let council know of the cost estimates for the following repairs:

- 1. Tyree Street ≈ \$29,000
- 2. School Street ≈ \$14,700
- 3. Sycamore Street ≈ \$16,800
- 4. Henry Loving Street ≈ \$24,750

Josh Crist made a motion to approve the street repairs as presented. Holly Jeffers seconded the motion and it passed unanimously.

Mayor Pridemore informed Council that the maintenance dump truck is currently down for an unknown time. The truck is currently at Mid-State Ford being checked out to see what the issue is. All street repair projects are on hold until the dump truck situation is resolved.

MTA (Mountain Transit Authority) has sent a letter asking Council to approve a donation of \$1,200 for their 2024-2025 fiscal year as MTA provides the only public transit within Ansted. Greg Brewer made a motion to approve the \$1,200 donation to MTA. Motion was seconded by Anthony Harmon and passed unanimously.

Mayor Pridemore reminded everyone of a Public Hearing on Friday, April 19, 2024, at 3:30 PM at Council Chambers for a demolition grant application on behalf of the Midland Trail Community Center (MTCC). With no further business to conduct, Josh Crist made a motion to adjourn the meeting, seconded by Greg Brewer. Motion passed unanimously.

Dale & Wavie Chappell / Halstead Street

At 6 P.M. Chairman Mike Fox called the $1^{\rm st}$ meeting to order. Those present, in addition to the Town Representatives, were Dale Chappell and Tera Chappell (wife).

Dale Chappell addressed the board to explain the reason for his variance request. He would like to build a garage closer to the property line than current zoning law allows.

After discussion between the board and Mr. Chappell, Craig McVey made a motion to approve the variance request to allow Mr. Chappell to build his garage at his requested location. Gary Hogg seconded the motion, and it was approved unanimously.

Logan Syner / Laundromat on Midland Trail

(Logan previously attained a variance to go from B2 to B4 to allow him to have car sales lot.) Tracy explained that they would like to separate the current building in half by building a wall to divide it. They have already purchased five washing machines and five dryers.

John Hoffman explained that zoning codes are specific in what can be done on property zoned a certain way. Mr. Hoffman explained that a single piece of property cannot hold two separate zoning declarations,

and that each business would need to have a separate mailing address and the property itself would need to be divided according to the current code.

Gary Hogg made a motion to deny the variance request of allowing Logan Syner to have a laundromat on property he already has a variance on for a car lot. The board explained that he would need to separate the building and get two different addresses, etc. before moving forward with the laundromat. Motion was seconded by Craig McVey and passed unanimously.

Fred Hypes and Clay Riley from Thrasher Engineering gave council an update on ongoing activities concerning the sewer update, a \$1,000,000 grant from the Corp of Engineering has been obtain for inflow work of phase three, up in Log Town hollow, where it has been found that major ground water is entering the system. They asked the town to approved them to begin work on Phase Four, which is for inflow and pipe repair in other areas of the system, they will be beginning working with region four on obtaining an additional two and a half million dollars of grants, all this work would be done with no increase in sewer rates. They also indicated that they and the attorneys were answering the WV DEP notifications of violations that have been received. Additionally, information was updated on the monies received for the Plant upgrade and the Chestnutburg Road extension. Anthony Harmon moved that the town authorize

Thrasher to move forward with Phase four, seconded by Greg Brewer, motion passed unanimously. Fred Hypes and Clay Riley left the meeting at this time.

Recorder Wilson read the April 16, 2024, minutes from the Ansted Zoning Board (copy attached) case one being Dale and Wavie Chappell for Halstead Street, and case two being Logan Syner for a Laundromat on Midland Trail. Greg Brewer moved that council approve the zoning board decision to grant a variance to Dale and Waive Chappell in case one, motion was seconded by Josh Crist, motion passed unanimously. Greg Brewer moved that council approve the zoning board decision to Deny the variance request of Logan Syner at this time, Mr. Syner was advised that he would have to separate the properties and come back to the zoning Officer and Board, seconded by Josh Crist, motion passed unanimously.

Mayor Pridemore advised Council that Calab Carte's one year appointment to the Comprehensive Plan Committee had expired and he would recommend that he be reappointed for a three-year term. He also indicated that Allison Smith had moved away from the area and would need to be replace, he indicated that he had attended all the meetings so far and would recommend that he be appointed to take her place on the committee, with such short time remaining before they render a Plan, hopefully in the next six months. Josh Crist moved that Calab Carte be appointed for a three-year term and that Mayor Pridemore be appointed to take Allison Smith's place, seconded by Holly Jeffers, Motion passed unanimously.

Recorder Wilson read Resolution by The Town of Ansted, West Virginia Authorizing An Application With The State Of West Virginia For Small Cities Community Development Block Grant Funds on behalf of the Midland Trail Community Center, copy attached. Josh Crist moved for approval of the resolution as read, seconded by Josh Cameron, motion passed unanimously.

Recorder Wilson read A Resolution Formalizing Fair Housing Program for Town of Ansted (copy attached), also on behalf of the Midland Trail Community Center grant application. Greg Brewer moved approval of the resolution as read, seconded by Josh Crist, motion passed unanimously.

Councilman Josh Crist spoke on behalf of a resolution in support for the Fayette County Fire Levy. Recorder Wilson read a resolution in support of the Fayette County Fire Levy, Josh Crist moved approval of the resolution as read, Greg Brewer seconded the motion, motion passed unanimously.

Recorder Wilson read a resolution in support of the Fayette County Law Enforcement Levy, Josh Crist moved approval of the resolution as read, Josh Cameron seconded, motion passed unanimously.

Recorder Wilson read a resolution in support for the Fayette County Public Libraries Levy, copy attached, Josh Crist moved approval as read, Josh Cameron Seconded, motion passed unanimously.

Mayor Pridemore indicated that he had gotten updated quotes on doing paying work on Florence Street east of Oak, School Street, Sycamore Street, Tyree Street, Henry Loving Street and Holly Street, low bid was \$85,108.00, by Jane Lee Enterprises. Mayor Pridemore advised that Lovers Leap Baptist was purchasing a Drop inlet, and 280 feet of Covert, for \$6,200.00 to help with water control, so that Henry Loving could be paved, Gensis Health Care had been requested to provide \$10,000 of assistance on Tyree street, and that Ansted Baptist Church had been requested to provide \$5,000 of assistance on Holley, along with a request to Wallace and Wallace. Mayor Pridemore moved to accept Jane Lee's bid, Greg Brewer seconded, motion passed unanimously.

No none showed up to present for Fall Soccer at Ballfield.

Holly Jeffers began a discussion about the Food Truck License of \$25.00 and that the Ansted Heritage Festival did not realize that they need to advise the trucks of this fee. John Cashion asked if the Council would waive part of the fee, maybe consider charging ten dollars. He was under the impression that the AHF committee needed to collect this from the food trucks. Lori Osborne indicated that most towns in the area charged a business license fee, of which the town of Ansted is \$25.00 and that the town was willing to collect it in June and give the food trucks at the festival a license that covers June of 24 and June of 25, instead of the normal July 1st to June 30th time frame. Lori Osborne advised Mr. Cashion that if the Committee would give her the names of the trucks coming, she would mail each an application and a letter. Greg Brewer indicated that five of the seven trucks noted to be coming to the festival had been purchasing town license's annually and that he had been in contact with them concerning the requirement of the town license for the Country Roads Festival to be held in September. Recorder Wilson moved that the \$25.00 fee be charged to the food truck vendors at the Ansted Heritage Festival in June of 2024 with the consideration of the extra two weeks of time, so that this license would be good for 2024 and 2025. Josh Cameron seconded the motion, motion passed unanimously.

Holly Jeffers requested funding for purchase of Flowers and other items for beautification of the town, Recorder Wilson moved that the Town commit up to \$2,500.00 to this project. Greg Brewer seconded the motion, the motion passed unanimously.

Town Clerk Patricia Breeden gave council a sample and cost information on doing a direct mail Town of Ansted Newsletter, she recommends publishing four times a year, at a cost of approximately \$200.00 per time. Recorder Robert Wilson moved that council fund publishing two newsletters at this time and then revisit with information about the effectiveness of the newsletter. Josh Cameron seconded the motion, motion passed unanimously.

All three town clerks presented information on and requested to attend the WV Municipal League Annual Conference in Huntington WV, August 6-9, 2024. Each presented why they would like to attend but had no plan of covering the office during this time. Mayor Pridemore reminded the council that he did not attend last year because of coverage. Flood Plain Manager Robert Wilson mentioned that he had received four events to attend concerning

Flood Plain information, and asked Police Clerk Breeden the amount spent last year for her to go to Alabama for police clerk training, somewhere around \$2,000.00, Recorder Wilson moved that Council go into executive session at 7:56pm, Josh Crist seconded the motion, motion passed unanimously.

At 8:34 pm. Recorder Robert Wilson moved to come out of executive session, seconded by Josh Cameron, motion passed unanimously.

Josh Cameron moved that request for attendance at the WV Municipal League Annual conference be tabled at this time until more information could be provided to council on this matter. Seconded by Greg Brewer, the motion passed unanimously.

With no further business to conduct, at 8.36 pm, Greg Brewer made a motion to adjourn the meeting, seconded by Josh Cameron. Motion passed unanimously.

The Town of Ansted held its regular monthly council meeting on Thursday, June 6, 2024, at the Ansted Council Chambers, located at 104 Cemetery Street, Ansted, West Virginia. Those in attendance were Mayor Stephen Pridemore, Recorder Robert T. Wilson, Councilmembers Josh Crist, Greg Brewer, Anthony Harmon, and Holly Jeffers. Councilmen Josh Cameron was absent. Citizens: Richard McVey, Maggie Crist, Nora Crist, John Barnhouse, John Eades, Dennis Mullins, Rennis Ward, Mitch Carte, Robert Thompson, Richard "Dickie" McVey.

Mayor Pridemore called the meeting to order at 6:30 PM. Councilman Greg Brewer led the meeting off with the Pledge of Allegiance and Councilperson Holly Jeffers led everyone in prayer.

The May 2024 minutes and a copy of the May Financial reports, as of May 30, 2024, not reconciled, with Clerk Siobhan Wilson being on vacation, had been provided to council prior to the meeting. Greg Brewer moved that they be approved as presented to council, seconded by Anthony Harmon, motion passed unanimously.

The council was provided with a Sewer Project Update Memo, dated June 3, 2024, from Thrasher Engineering, copy attached.

Mayor Pridemore recommended to Council that he and Clerk Siobhan Wilson attend the WVML Annual Conference in August at an estimated cost of \$2,200.00. Greg Brewer moved for them to attend, and expenses paid by the Town, seconded by Josh Crist, motion passed unanimously.

Jessical Gill – Autism & Special Needs Registry was unable to make the meeting.

Recorder Wilson read a resolution of the US Army Corps of Engineers; copy attached. Greg Brewer moved approval of said resolution, Anthony Harmon seconded, motion passed unanimously.

Recorder Wilson read budget revision three of three for the general fund with a net increase of \$84,000, copy attached. Anthony Harmon moved approval of the revision as read, seconded by Greg Brewer, motion passed unanimously.

Recorder Wilson read budget revision two of two for the Coal Severance fund with a net increase of 1,650, copy attached. Greg Brewer moved approval of the revisions as read, seconded by Anothony Harmon, motion passed unanimously.

Mayor Pridemore invited the delegation from VFW post 7695, to discuss the maintenance requirements of the VFW Memorial in the Town of Ansted and a proposal for the Town to take over the upkeep. Mitch Carte advised that the group was aging and losing membership and that the Eades family have been maintaining the site for some time. John Eades said that they have been scrubbing the bricks with a pressure washer twice a year, pulling plants, etc. from between the bricks, mulching the pine trees once a year, keeping the grass cut and trimmed, cleaning up behind animals as needed. The large flag normally needs to be replaced about every three years at an expense of \$850.00, and each service flag lasts about a year and costs about \$20.00 per flag. He indicated that someone would have to take over the Brick ordering and taking of donations. They would like for one of their members to be a second signature on the checking account holding the funds, but Mayor Pridemore advised that if the Town took over the account it would be treated as any other fund account with town personnel only on it, with documentation provided to the VFW monthly showing donations and expenditures. The Mayor also inquired if the VFW was a 501C3 Corp, which they advised that it was, and what happen to the property if the Post disbanded, Mitch and Rennis were of the opinion that the property would be transferred to the State VFW Post, but they would inquire into that matter. Recorder Wilson indicated that he was of the opinion that the Memorial was a great asset to the Town and that the Town should take over the maintenance and funds, he would like to have a legal opinion from the Town Attorney, that this was a legal course of action before both parties commit to it. The matter was tabled until such a legal opinion was obtained.

Josh Cameron (although absent) made a request to the mayor that the town purchase a Hometown Heroes Banner for his uncle that donated the property for the VFW Memorial. Josh Crist moved that the Town purchase a banner for Mr. William G. "Bill" Leake, Holly Jeffers seconded the motion, motion passed unanimously.

Mayor Pridemore had polled the council considering going ahead and paving Bell Street for a cost of \$6,631.00 while the pavers were in town and paving Henry Loving Street, which Bell Street is across from Henry Loving, all members had agreed. Greg Brewer moved that the action of paving Bell Street be ratified and approved in the amount of \$6,631.00, seconded by Holly Jeffers, motion passed unanimously.

Mayor Pridemore indicated that water drainage work needed to be done on Holley Street before paving was to be done, that he had gotten quotes on trench drain pipe, 10 inches in diameter, 10 feet long, two sections would be needed at the upper end of Holley Street along with approximately 140 feet of 10 inches culvert to go across the Skaggs/Holsclaw property to

drain the water over the hill, and that two sections would be need down at the Crist property to handle drainage there, the cost of the pipe would total \$5,294.31, with the town doing the labor. Greg Brewer moved approval of the purchase, Anthony Harmon seconded, motion passed unanimously.

Mayor Pridemore presented a request from the Municipal Court Judge, Teresa Dorsey, to move city court held on the 3rd Tuesday of the month at 5:30 PM be moved to 5:00 PM. Greg Brewer moved that the court time be changed to 5:00 PM, Anthony Harmon seconded, motion passed unanimously.

Mayor Pridemore advised Council that he had received the resignation of Councilman Josh Crist effective June 30, 2024, he was recently elected to the Fayette County Board of Education and could no longer serve in an elected paid position. Greg Brewer moved acceptance of the resignation with regret and congratulations, Anthony Harmon seconded, motion passed unanimously. Mayor Pridemore recommended that Margaret "Maggie" Crist fill his term. Greg Brewer moved approval of Margaret "Maggie" Crist for the remaining term of Josh Crist, to be sworn in at the July 11, 2024, Council meeting, seconded by Robert Wilson, Holly Jeffers, Anthony Harmon, Greg Brewer, Stephen Pridemore, and Robert Wilson voted for the Motion, Josh Crist abstained. Motion passed.

Mayor Pridemore indicated that an additional amount had been placed in the Budget for Westlake Cemetery, Recorder Wilson indicated that the Cemetery received funds in November, and that the Cemetery had funds to pay for upkeep this year, and he moved that these funds be reallocated to another need in the town, seconded by Greg Brewer, motion passed unanimously.

Mayor Pridemore reminded all that the first Thursday of July was the fourth and because of the holiday the council meeting would be moved to July 11, 2024.

With no further business to conduct, at 7:20 pm, Greg Brewer made a motion to adjourn the meeting, seconded by Holly Jeffers. Motion passed unanimously.

- c. Operate, maintain, replace, and rehabilitate the Project upon completion, and as constructed, in accordance with the regulations or directions by the Secretary of the Army and all without cost to the United States Government;
- d. Pay its percentage share of total project costs as required by The Water Resources Development Act of 1986, (Public Law 99-662), as amended, and by the Project Partnership Agreement;
- e. Prevent obstruction of or encroachment on the Project that would reduce the level of protection it affords or that would hinder operation and maintenance thereof; AND
- f. Comply with the provisions of the Uniform Relocations Assistance and Real Property Acquisitions Policies Act of 1970, Public Law 91-646, approved 2 January 1971; and Section 221, Public Law 91-611, approved 31 December 1970, as amended.
- Section 3: The Town of Ansted hereby approves and ratifies all prior participation and acts of the Town of Ansted, by and through its officials, with the Department of the Army, Corps of Engineers, in relationship to said Project.
